#### Referendum Signing Event Review/ H4895 Comments

I'm sure you are aware that our wonderful Governor signed into law, H4885 under an emergency order on the very controversial new gun law changes. It was to become effective on October 23, 2024 but she made it effective immediately. It was such an emergency to sign this into law in her eyes, but very little of the law is being implemented because no one in the government knows how to implement many of the provisions of the law.

The changes to the new LTC firearms licensing have been postponed for 18 months because the State Police Commander does not have the proper language to enforce it.

Very little changes have taken place as to which long guns are legal or not legal because they have not developed a list of firearms that are approved for sale. It is pretty much the same as before the new laws went into effect. Pistols which were legal before the new law are still legal now. So-called assault weapons that were legal to sell before are still legal to sell now.

The only new thing being done now is recording all ammo sales to the person purchasing. So, as you can see, this was truly an emergency.

The story on the new gun laws is just beginning over 90,000 signatures were given to the Secretary of State in Massachusetts to get a repeal question on the 2026 ballot for voters to decide. Hopefully this gets approved and voters will make the decision on this. There will be more to come as GOAL releases the news. Steve Podlesny
